Congratulations, you and your dog(s) are entered in the DDTC July Agility Trials. You will find a copy of your dog's information for the July 31 & August 1, 2010 DDTC Agility Trial on a separate/email page. Please read this carefully and make sure your dog's name(s) and registration number(s) are correct and that it is entered in the proper classes. If your confirmation has the height card marked **measure** you either need to have your dog measured and/or must pick up your armband numbers from the trial secretary.

Our judge is a Volunteer Measuring Official (VMO). In accordance with AKC regulations, all dogs that do not have a permanent or valid temporary Jump Height Card issued by the AKC must be measured for a Jump Height Card regardless of the jump height entered. Measuring will be held prior to the start time each day, and at times announced during the day. Any dog **without** a jump height card, including those jumping 24" or 26", **must be measured** before you can pick up your packet and run your dog.

Directions:

The trial will be held at the DDTC Building, 3040 East River Rd., Dayton, OH 45439

From I-75 take Dryden Rd. Exit-50A

At the end of the exit ramp, turn West onto Dryden Road and go to the Traffic light (see Holiday Inn) Turn left onto Arbor Boulevard and proceed until it ends into River Road. Turn left onto River Road and proceed approximately seven-tenths of a mile (Passing Mandalay Banquet Center) Orbit Industrial Park building is the last building on the left just before the pond. Turn left into parking lot and go to the right-back side of the building.

Please Note:

You are, of course, expected to clean up after your dog. There will be equipment and supplies to do so located at several places around the building. Please respect the property of the Dayton Ski Club and do not take your dogs past the overhead wires toward the pond. The pond is NOT our property.

Limited indoor crating will be available with preference given to workers. Due to the limited amount of space indoors there will be **NO EX-PENS** allowed. You will be permitted to set up tents outdoors on the DDTC property after 6 pm on Friday evening as space permits. There will be no security provided overnight for those who choose to leave equipment outdoors. There is also no on site camping available.

General Running Order:

All classes will run small to large both days. Within an Excellent jump height; the B dogs will run, then the B Preferred, the A dogs and then the A Preferred dogs. Within a Novice jump height; the B dogs will run, then the A dogs and then the Preferred dogs.

Briefings and walk-thrus for Excellent Standard will be held at 7:45 a.m., runs will begin at 8 a.m.

The ring will start with Excellent Standard, followed by Open Standard, Novice Standard, Excellent JWW, Open JWW, and Novice JWW.
